SCHOLARLY INTERESTS

- The vast majority of my scholarship addresses issues related to lawyer regulation, globalization, and the legal profession. Despite the rapid pace of developments, this is an underdeveloped academic field and relatively few academics have a similar scholarly focus. My scholarly goals vary depending on the particular article. My articles include “[transparency](#)” articles, designed to bring certain lawyer regulation developments into the public domain for discussion and debate; [exploration or “mapping”](#) articles that examine an important new development that is not widely known; [commentary and “reflection”](#) articles; [reform proposals](#); [teaching-related](#) articles; and [“outreach”](#) articles. (I have written some [miscellaneous](#) articles that do not fit into any of the categories listed above.)
- In addition to my own articles, I have coordinated four global legal practice-related Symposia in order to memorialize global legal practice developments not widely known within the academy or the profession. See the 2004 and 2008 Penn State International Law Review Global Legal Practice Symposia (publishing papers from the Florence and Amsterdam meetings of the Association of Professional Responsibility Lawyers); the 1999 Dickinson International Law Review Symposium (publishing submissions from the *Paris Forum on the Transnational Practice of Law*); and the 2010 Journal of the Professional Lawyer Symposium on the FATF and Legal Services (including articles by three of the four lawyers who represented the world’s legal profession in negotiations with the FATF, which is a 34-country intergovernmental organization.)
